1.0 Candidates have the option to transcript the passage in Hindi either on Manual Typewriter (Key Punching Type) or on Desktop Computer. A link will be provided on RRB Allahabad's website to the above shortlisted candidates to submit options for Stenography Test either on Desktop Computer or on Manual Typewriter.

2.0 The candidates who are opting Manual Typewriter for transcription of passage may bring their own Hindi typewriter (key punching type) alongwith them for the Stenography Skill Test. Arranging of Hindi typewriter in time for the test will be the sole responsibility of the candidates. If typewriter brought by the candidate develops any snag or fails during the test, then no extra time or alternate arrangement whatsoever shall be made by RRB. The typewriter will not be provided by RRB under any circumstances.

However, Candidates who opt for Desktop Computer for transcription of passage in Hindi, Desktop Computer will be provided by RRB Allahabad & **Key Board layout** will be **Remington (GAIL)**.

The dictation of Passage in Hindi will be of 10 minutes @80w.p.m & time allowed for transcription of passage will be 75 minutes.

3.0 The venue, date & reporting time for stenography test will be intimated/advised through RRB Allahabad's website. Call letter for Stenography Skill Test indicating date and Venue will be sent to above shortlisted candidates by registered post.

4.0 Don't bring any banned items / Electronic Gadgets such as Mobile phones, Pager, Watch, Bluetooth enabled devices, Calculators, Camera etc. since these are not allowed inside the premises of Stenography Test Venue.

5.0 The candidature of above candidates who do not fulfill the eligibility conditions prescribed in the notification and conditions stipulated for written examination & Stenography test including any deficiency in application are liable to be rejected at any stage of recruitment process. Further if the name of any candidate finds a place in the live debar list, his/her candidature will be rejected at any stage.
